

## MWG STALLION NOMINATION AGREEMENT for 2011

This Agreement is by and between the **American Morgan Horse Institute, Inc. ("AMHI")** and \_\_\_\_\_ ("Owner").

Whereas, Owner wishes to promote the value of the stallion known as \_\_\_\_\_ and AMHI wishes to promote the Morgan breed and is organizing an event in 2011 to be known as the Morgan Weanling Gala to be held at **The Jubilee Regional Morgan Horse Show** (the "Gala");

1. **Stallion Nomination.** Owner nominates and AMHI accepts the stallion known as \_\_\_\_\_ AMHA # \_\_\_\_\_ as an eligible sire for foals in the Gala. Owner represents to AMHI that the stallion is registered with the American Morgan Horse Association ("AMHA"). AMHI shall accept any get of the named stallion and out of mares registered with the American Morgan Horse Association into the Gala competition.

2. **Promotion of Gala.** Subject to the contingency set forth below, AMHI shall organize and promote the Gala, including the offering and payment of prize money to the winning foals. The actual amount of prize money offered and paid shall be approximately the amount remaining after all costs of organization and promotion of the event have been subtracted from the total nomination fees collected prior to the event. This prize money shall be awarded to the ten placings in the Gala according to a specific percentage formula to be provided to the stallion owners by August 31, 2011.

3. **Nomination Fee.** In consideration of AMHI's acceptance of the nomination and agreement to organize and promote the Gala, Owner shall pay the nomination fee of \$ **3,000**. Owners who nominate the same stallion in consecutive years will receive a ten (10 %) percent discount on each consecutive year nomination fee. The nomination fee may be paid in two installments. The first installment of not less than \$ **1,000** to be paid together with Owner's delivery of this Agreement to AMHI not later than December 1<sup>st</sup>, 2009. The second installments representing the remaining balance due to be paid not later than February 1<sup>st</sup>, 2010. Payments shall be made in good funds by check or credit card. In the event that owner chooses to pay by credit card, there will be an added administrative fee of 3% of the amount charged to the indicated credit card to defray incremental expense to AMHI.

4. **Contingency.** AMHI's obligation to proceed with organization and promotion of the 2011 Gala shall be contingent upon receipt of at least \$45,000.00 of nomination fees (representing 15 to 17 nominations fully paid) on or before August 1, 2010 (the "Minimum Fees"). In the event the Minimum Fees have not been received by that date, AMHI shall have the election to cancel the Gala and return all nomination fees paid to date.

5. **Termination for Non-Payment.** If the balance due on a nomination is not fully satisfied by August 1, 2010 and AMHI has not elected to cancel the 2011 Gala, then the nomination for that stallion shall be deemed voided and funds already paid will be retained by AMHI without liability to owner.

6. **Substitution of Stallion.** Owner shall have the limited right to substitute another stallion for the stallion named above, only in the following circumstances: (i) the stallion named above has died or is certified sterile by qualified veterinarian; (ii) AMHI is advised of same in writing, together with the name of the substitute stallion, no later than August 31, 2010 prior to the 2011 Gala; and (iii) the replacement stallion is also registered with the AMHA.

7. **Entire Agreement.** This is the entire agreement of the parties with respect to stallion nomination for the Gala and production of the Gala, superceding any and all prior oral or written agreements, and may be amended only in writing signed by both parties.
